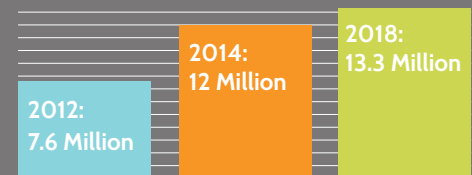

Medi-Cal Enrollment Growth



Between 2013 and 2014, Medi-Cal experienced the largest growth in the program's history as program enrollment increased by 4.5 million, or nearly 60%.

Caring for More Californians than Ever Before

The ACA significantly expanded Medi-Cal coverage eligibility and California's managed care plans have quickly scaled up to serve new populations while continuing to drive quality and affordability across the board.



Managed Care Delivers Cost Savings

Medicaid Managed Care leads to better care delivery and coordination and crucial cost savings—which allows the state to reinvest these dollars toward improving care for all beneficiaries.

- More predictable state budgeting

Medi-Cal spending has grown more slowly than employer-based or individual coverage on a per-person basis.

Nationally, health plans saved Medicaid \$7.1 billion in 2016

Care Delivery: Local Options

Medi-Cal managed care plans are focused on meeting the unique needs of the populations they serve and, in recent years, have shifted contracting and care management models to better care for the expanded pool of beneficiaries.

- Two-Plan
- County Organized Health Systems (COHS)
- Geographic Managed Care (GMC)
- Regional Model (RM)

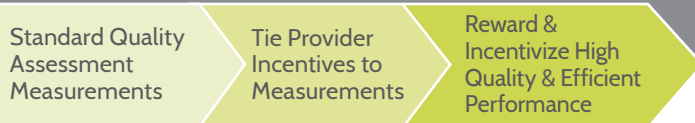

To help this high need population, California has created the, Cal MediConnect program which offers 415,000 patients eligible for both Medicare and Medi-Cal (Dual Eligibles) in seven pilot counties better access and fully coordinated care through managed care plans.

Cal MediConnect enrollees have access to a full array of providers, supports, and services based on their needs, helping them stay in their homes, manage their medications and chronic conditions, and avoid institutional care.
