## CAHP Names New Vice President of State Medicaid Policy and Legislative Advocate

Kemp has an extensive background in the Medi-Cal program and previously worked in the director's office at the Department of Health Care Services (DHCS) where she worked on projects directed towards quality improvement in publicly financed health care programs and managed implementation of a \$3.3 billion Medi-Cal program waiver designed to reform California's public health care delivery systems. Prior to joining DHCS, she served as a special assistant to state Board of Equalization member Betty T. Yee. Kemp has a master's degree in business administration from Mills College in Oakland.

Hampton previously served as the Director of Public Policy for LeadingAge California where he was responsible for the planning, development and implementation of its public policy activities in the healthcare arena, including: assisted living, skilled nursing, Medi-Cal, Medicare and other long-term care issues. Hampton also previously served as an independent consultant to the California Association of Rural Health Clinics, where he directed the advocacy and

communications efforts for the association. Prior to consulting, he served in the Sacramento County Executive's office as a budget and policy analyst, as well as interim Legislative Officer for the county. He began his career serving as a Legislative Assistant for the California Chamber of Commerce, where he focused on healthcare and environmental issues. Hampton received his Master's degree in Public Administration from University of San Francisco and received his Bachelor's degree in Government from California State University, Sacramento.
