Dr. Rideout is currently President and CEO of the Integrated Healthcare Association ([www.ihg.org](http://www.ihg.org)). The Integrated Healthcare Association is a California statewide multi-stakeholder leadership group that promotes quality improvement, accountability and affordability of health care. In the 4 years since Dr. Rideout became CEO, the organization has doubled revenues each of the last 3 years, has more than tripled the number of industry scaled programs and has doubled the number of staff while continuing to maintain surplus reserves and a 100% employee retention rate in 2018. IHA operates one of the nation's largest Alternate Payment Models, covering nearly 10 million HMO members and maintains one of the nation's largest All Payer Claims Data Bases, covering quality and total cost of care performance for over 29 million Californians across commercial HMO, PPO, ASO, individual, exchange, Medicare, Medicare Advantage and Medi-Cal.

Dr. Rideout also holds academic appointments with Stanford University as Adjunct Professor, Department of Medicine, School of Medicine, and the University of California, Berkeley Haas School of Business, teaching on topics related to healthcare technology, services and innovation. At Haas, Dr. Rideout is a 15 year faculty member and teaches a highly rated, regular 2<sup>nd</sup> year MBA course on venture capital investing in healthcare technology and services, including digital health.

Dr. Rideout also serves as an independent director for the publicly traded Amedisys Corporation ([www.Amedisys.com](http://www.Amedisys.com)), serving on the Compliance and Quality Committees (chair), and as an independent director for the publicly traded HMS Corporation ([www.hms.com](http://www.hms.com)). Dr. Rideout was also recently selected as an adviser to the Bain Capital Double Impact Fund ([www.baincapitaldoubleimpact.com](http://www.baincapitaldoubleimpact.com)), a \$390 million venture fund started in 2015 committed to both financial and social returns, now in Fund II. Dr. Rideout is part of the health team and currently serves on the board of directors for Broadstep Behavioral Health ([www.broadstep.com](http://www.broadstep.com)). Until its successful acquisition in December 2018 by ResMed, Dr. previously served as an independent director for the private equity backed EHR firm MatrixCare ([www.matrixcare.com](http://www.matrixcare.com)), where he provided clinical, health IT/analytics and healthcare policy expertise. Dr. Rideout also currently serves as a board member of the California Department of Managed Care Financial Standards and Solvency Board and previously was a 15 year board member of the Pacific Business Group on Health. Dr. Rideout is also a 9 year board member and past chair of Contra Costa Interfaith Housing, a northern California regional not-for-profit that provides permanent housing and services to low income families. Previously Dr. Rideout was a 15 year board member of Medical Teams International, a Portland based not-for-profit providing international disaster relief.

Previously Dr. Rideout was SVP, Chief Medical Officer for The TriZetto Group, leading strategy around development and delivery of a comprehensive suite of products and services that enable payers, providers and employers improve the cost and quality of care. Dr. Rideout also served as the global leader of the healthcare division for Cisco Systems Internet Business Solutions Group, and Cisco's Chief Medical Officer, working with health care and public sector leaders to help them use technology to accelerate transformation of the health care industry, and also provided strategic leadership for health benefit value purchasing decisions for Cisco's 65,000 employees and dependents worldwide. Prior to Cisco, Dr. Rideout was Chief Medical Officer and SVP for Blue Shield of California and head of Quality Management for Blue Cross of California/WellPoint. Operating through Rideout Advisors LLC, Dr. Rideout has also served as an independent consultant to several organizations, including Covered California, California's State based Exchange (first Medical Director), GE Ventures (Executive in Residence), the American Heart Association and numerous start-up companies.

Dr. Rideout completed his residency training in internal medicine at University of California, San Francisco and is a Fellow of the American College of Physicians. He received his medical degree from Harvard Medical School and his undergraduate degree from Stanford University. He also holds a master's degree in Philosophy, Politics, and Economics from Oxford University where he studied as a Rhodes Scholar.
